Hon. Mr. CHAU TSUN NIN, J.P.
BARRISTER-AT-LAW.

Mr. Chau is one of the most influential social magnates of Hongkong. He is a native of the Tungmoon District, Kwongtung Province, but was born in Hongkong in 1893. When he was but seventeen years old, he was graduated from the St. Stephen's College and in the following year, he set sail to England to continue his studies and to attain a thorough education. He was graduated with the B.A. degree and the title of Barrister-at-law from Oxford University England in 1914 and ever since, he practices his profession in the Colony. Bright and smart as Mr. Chau is, he has rendered himself to the commercial world. He is general manager and director of the Yuen On Steamship Co., Ltd.; The China Emporium, Ltd.; the Chun On Fire Insurance Co.; manager of the Hongkong & Kowloon Land & Loan Co., Ltd.; director of the Wo Shing Co., Ltd.; committee of the Fire Insurance Association of Hong Kong, Marine Insurance Association of Hongkong & Canton. Besides these, Mr. Chau is partner or stockholder of many firms in Hongkong.

Though he is always busy with his own work, Mr. Chau is very attentive in social affairs. He is a member of the Legislative Council, which he began consumption since 1931; and member of the Sanitary Board. He was appointed Justice of the Peace of Hongkong since 1923 and has been holding important positions in different public-welfare organizations. The most note-worthy ones are finance committee of the St. John Ambulance Association; Hon. president of the Chung Sing Benevolent Society; college council of the St. Stephen's College; Hon. Vice-president of the Hong Kong University Union; Hon. President of the South China Athletic Association; Vice-president of the Boy Scouts Association; Hon. Director of the Chinese General Chamber of Commerce; Ex-president of the Tung Wah Hospital; Justice of the Po Leung Kuk; ex-president of the Inland Steamship Association; and director of the Hongkong Society for the Protection of Children.

Speaking generally, Mr. Chau has done a great deal to the Hongkong Government as well as to the Chinese population living in the Colony.
